- Joseph Armstrong De Laine, Sr. (retired clergyman) and Mattie Belton De Laine (retired public school teacher)

The venue for this home was created by purchase of a segment of land from Joseph and Marjorie Belton to the east and by land purchased on the west side owned by Charley and Evelyn Maxwell. Thus creating a legal size lot suitable for erecting a home.

Building completed and initially occupied in 1971 (approximately 20 years after the community was established).

# More about them, community activities, interesting accomplishments, where from, where educated. Joseph Armstrong De Laine, Sr. (1898-1974)

- Born and reared in South Carolina
- -Received a BA Degree in education and a Bachelor of Theology degree from Allen University, Columbia, SC. Awarded an honorary doctorate's degree from Allen University and from Monrovia College, Monrovia, Liberia.
- -Served as a church pastor for approximately 45 years in South Carolina and New York States
- -Founded De Laine Waring Church in Buffalo, New York
- Taught in segregated public schools in South Carolina approximately 16 years.
- -Active in local South Carolina civil rights leadership roles from 1940 to 1955. Particularly a major role in the of school desegregation. His activities culminated in the destruction of his home by arson in 1951, the destruction of the church (also by arson) where he was assigned as pastor in 1955 and he was given to leave town and the state within ten days or die in October 1955. Upon his refusal to leave an armed

posse arrived apparently to implement the consequence of their demands. He returned their gunfire, escaped and ultimately found haven in New York State.

-He was posthumously awarded The US Congressional Gold Medal in 2004 for his local leadership role in civil rights efforts initiated in South Carolina that ultimately led to the May 17, 1954 US Supreme Court Decision referred to as *Brown v. Board et al.* 

# Mattie Belton De Laine (1907-1999)

- -Received a BA Degree in elementary Education from Allen University, Columbia, S C. Additional educational studies were completed at the University of Buffalo, Adelphi College and Hofstra College.
- -Most notable of her activities other than family and profession was her supportive role in the civil right activities led by her husband during the 1940s and early 1950s.
- -Taught in public schools of South Carolina and New York State for approximately 43 years.

- -Appointed by President George W. Bush as a Commissioner on the 50<sup>th</sup> Anniversary Presidential Board of Commissioners for *Brown v. Board el al.*

- -Author of "Dawn of Desegregation."
